Dear Sir,
Thank you for your instructions to Additional Commissioner/ Asst.Revenue Officer (ARO) Rajarajeshwari Nagar to provide the RTI Information to me as a response to my mail

But I feel very Sorry because, the Asst.Revenue Officer of Raja Rajeshwari Nagar who is the Public Information Officer and also the signing authority to Khatas and other revenue records is continuously misguiding all higher officers and elected representatives by his mis-information.

I have asked information and documents under RTI Act regarding the documents of Compliance with Supreme Court Order in SLP (Civ) (CC) 5582-5583/2010 in which the Civil Court decree order in OS 2355/2001 and High Court Order in RFA 1121/2005 & 1628/2005 were merged and upheld. And I have not asked for the above said judgments or letters from Deputy Commissioner/ Assistant Commissioner as all these documents are already with me.

But the ARO has sent a letter informing that he is sending the letters of DC, AC & above mentioned Judgments. However he sent only letters of DC & AC which are as old as 2002. These documents including Asst.Commissioners order of 18-9-2001 were placed before the Civil Court during its proceedings and also before Supreme Court during it, High court & Supreme Court during judicial proceedings and the above Judgments were pronounced only after taking cognizance of above mentioned documents and Asst.Commissioner's Order.

With the Supreme Court Judgement the matter attained finality and complying it is the duty and constitutional obligation of each and every one. Instead of Complying with it the Addl.Commissioner and ARO of Rajarajeshwari Nagara misguiding everybody by showing and sending the age old letters.

I am attaching the scanned copies of documents sent by ARO here for your perusal and request you to go through my RTI Application attached in my earlier letter linked to this mail.

I request you to provide the RTI information as I sought i.e. documents

of compliance with Supreme Court Order . If not complied with, pls provide the information and documents regarding the disciplinary action taken against such erring officials for not complying the Supreme Court Order.
